14/108 Public Session:-

A member of the public present expressed concern over the increase of HGV's on York Road and the ongoing problems were discussed.

County Councillor M Jordan and District Councillor K McSherry agreed to look into the points raised i.e. extending the speed limit and footpath and also to request further weight limit signage.

Mr Jan Strelczenie spoke to the Parish Council about the Oldways Regeneration Project and reported that the Parish of Hemingbrough Historical Heritage Society (PHHHS) are commencing work in the Oldways to tidy up old course of the River Ouse, open up the ponds, create pathways and provide tables and seating.

Mr Robert Procter advised that the PHHHS has also taken ownership of the Hearthstone Filling Station and intend to demolish the filling station and create a Memorial Garden to commemorate the Centenary of the First World War and also to remember the deceased of all wars from Hemingbrough and the surrounding area.

The Chairman congratulated the group on all the work that they are doing.

14/109 Listen to reports from County and District Councillors:-

County Councillor M Jordan advised that the CEF meeting scheduled for Monday 29th September had been cancelled and that the next meeting would be held on Wednesday 15th October.

District Councillor J Deans reported that due to land supply issues the Selby District Council Core Strategy and Local Plan was now out of date and so the National Planning Policy Framework was now being used as a guide for planning applications.
