#### 14/098 Public Session:-

As no members of the public were present no public session was held.

#### 14/099 Listen to reports from County and District Councillors:-

District Councillor K McSherry advised that Selby District Council will be contacting all Parish Councils to ask for their views on the suitability of the current polling station.

District Councillor J Deans read out the response received from Joe O'Sullivan – Selby District Council Planning Officer in relation to the query raised at the July meeting concerning the open day at the Ranch Caravan Park.

Councillor Deans also reported that at the Full Council Meeting held on 24<sup>th</sup> June the Executive report included potential sites for the travelling community and noted that Selby District Council officers are consulting with colleagues at North Yorkshire County Council who identified a number of potential sites within County ownership which may be available to SDC including land on the A163 at Barlby and discussions are on-going.

County Councillor M Jordan noted that alterations are planned for the east end of Hull Road.

The clerk advised that Mark Lumby – Highways had raised concern that the Japanese Knotweed may have spread outside the treated area.
